Sir/Madam,

In supersession to this Ministry's letter No. U-12012/36/2016-ME.I dated 10.06.2016 and with reference to your fresh compliance/representation submitted in the light of directive of the Supreme Court Mandated Oversight Committee (OC) dated 13.06.2016, I am directed to say that the OC has approved increase of intake capacity (100 to 150 seats) in MBBS Course at Lokmanya Tilak Municipal Medical College and General Hospital, Mumbai for the academic year 2016-17 subject to submission of the following:

- An affidavit from the Dean/Principal and Chairman of the Trust/Society/University/Company etc. concerned, affirming fulfilment of all deficiencies and statements made in the respective (i) compliance report submitted to MHFW by 22 June 2016.
- A bank guarantee in the amount of Rs. 2 crore in favour of MCI, which will be valid for 1 year or until the first renewal assessment, whichever is later. Such bank guarantee will be in (ii) addition to the prescribed fee submitted alongwith the application.
- An undertaking from the Chief Secretary of the State affirming fulfillment of all deficiencies and statements made in the compliance report. (iii)
- The OC has also stipulated as follows:-2.
  - (a) OC may direct inspection to verify the compliance submitted by the college and considered by OC, anytime after 30 September 2016.
  - (b) In default of the conditions (i) and (ii) in para 1 above and if the compliances are found in default of the conditions (i) and (i) and (ii) and (iii) and (i debarred from fresh intake of students for 2 years commencing 2017-18.
- The College is further directed to: 3.
  - Upload on its website the status of compliance with MSRs in respect of faculty, opioau on its website the bed occupancy and other requirements as on 10<sup>th</sup> infrastructure, clinical material, bed occupancy and other requirements as on 10<sup>th</sup> September, 2016 in the first instance followed by another update on the website/s as (i) on 20th September, 2016 and the status may be intimated to OC.

- Accordingly a Letter of Permission (LoP) for increase of intake capacity (100 to 150 seats) in Course at Lokmanya Tilah Mambai for the MBBS Course at Lokmanya Tilak Municipal Medical College and General Hospital, Mumbai for the academic year 2016-17 m/s 101 academic year 2016-17 u/s 10A of IMC Act, 1956 is hereby issued subject to furnishing documents/Bank Guarant documents/Bank Guarantee as per para I above alongwith another Bank Guarantee of required amount in favour of the second amount in second amou amount in favour of Medical Council of India, New Delhi valid for five years from a Nationalized/schooluled Delhi valid for five years (100 to 150 seats) Nationalized/scheduled Bank as per MCI's norms for increase of intake capacity (100 to 150 seats) in MRRS course with in MBBS course within 15 days to this Ministry. In the event of non-submission of the affidavit and Bank Guarantees within Bank Guarantees within the stipulated period, this Letter of Permission shall stand withdrawn.
- The Government Medical Colleges (Except those located in J & K, Andhra Pradesh and Telanagana States) shall contribute 15% of MBBS seats for which the LOP is granted for all India Quota.
- This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to the verification of the achievement of annual targets as indicated in your scheme and revalidation of performance Bank Guarantee. This process of renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed and a formal recognition of the Medical College is granted.
- The next batch of students in MBBS course against increased intake for the academic session 2017-18 will be admitted in the college only after obtaining permission of Central Government and fulfilling the conditions of OC stipulated in para 2 of this letter.
- Admissions made in violation of the above conditions will be treated as irregular and action 7. under IMC Act, 1956 & Regulations made thereunder will be initiated.
- Discrepancies, if any, may be brought to the notice of MCI and Central/State Government. 8.
- 9. Kindly acknowledge receipt of this letter.
